## Ocean Financial Home Equity Line of Credit Home Improvement Sweepstakes Rules

- **4. Contest Period:** The Contest begins on April 1, 2017 at 12:01 am EST and ends on June 30, 2017at midnight EST (the "Contest Period"). - **5. How to Enter**: <u>Automatic</u>: When you apply for and are approved for a Home Equity Line of Credit from Ocean Financial, you will automatically receive one entry for the contest. Limit one (1) entry per household. <u>Via Mail</u>: This method of entry will be available for the entire Contest Period.
