Ocean Financial is busy, we are growing, there is a lot going on and I hope you and your families are taking full advantage of the momentum at your Catholic Credit Union.

Earlier this year, we made a promise to review and lower our Visa credit card rates. We did just that as of June 1st and the new rates will be reflected in your June statement. I am not aware of a lower rate in the market. With our low rate, our rewards program and no balance transfer fees why support a "mega bank" every time you swipe your credit card?

Our members are taking advantage of our new No Closing Cost Home Equity Line of Credit. We are closing more loans than ever before, all with about a two week turnaround time. Our 1.99% APR introductory rate for one year has a lot to do with the popularity.

For almost a decade we have experienced a historic low rate environment. Even as the Fed cautiously makes upward adjustments, rates remain low. While there is no magic way for Ocean Financial to offer rates you may have been accustomed to in the past, I assure you our rates are consistently on the high end of the market. I encourage you to look at and compare our certificate rates; they are a good savings option.

After a bumpy rollout, our members are embracing our new online banking services. More and more of you log on regularly to review account activity, make transfers or pay bills with ease. Easy online loan applications, our latest eServices addition, have recently been implemented and, although in the early stages, are being used 24/7.

Last month I had a wonderful opportunity to attend a morning class with the fifth graders at St. Elizabeth Ann Seton Regional grammar school in Bellmore. They all earned a certificate for completing our "Let's Make Cents" financial literacy program. Interacting with them was fun and I was impressed with what they learned. It reminded me of my fifth grade class at St. Christopher in Baldwin.

For the 15th consecutive year I congratulate our four Patrick McNeil \$1,500 scholarship winners. This program, named after one of the greatest volunteers our credit union has ever had, also recognizes the effort of the applicants that were not selected with a \$100 prize.

Refinance Your Auto Loan and Save!
